- Graduate School Dean Ranjit Koodali Summary of Proposed Framework for Interdisciplinary Graduate Programs

Introduction

Dr. Lakshmi Reddi, the interim Provost, has requested the creation of a framework for interdisciplinary graduate programs. Leveraging Dean Koodali's experience as the Dean of the Graduate School and his background in developing interdisciplinary grants, he collaborated with Dr. Rick Marlatt to present their ideas.

Key Points

1. Purpose of Interdisciplinary Programs:

- The goal is to enhance the university's standing as an R1 institution by fostering collaboration among faculty from various departments.
- National Science Foundation and National Institutes of Health support the need for interdisciplinary education, emphasizing that teamwork can lead to innovative solutions.

2. Current Structure:

- Interdisciplinary graduate programs (IGPs) will not replace existing academic departments but will function similarly to current programs, such as Water Science Management and Molecular Biology.
- Faculty will continue to report to department heads while also engaging in IGP activities.

3. Administrative Support:

- The graduate school will facilitate conversations between faculty from different colleges and provide graduate assistantships to promote collaboration.
- An IGP Executive Committee will govern the program, supported by an Advisory Council including representatives from various academic and administrative bodies.

4. Faculty Recognition:

- We aim to offer incentives to faculty for teaching interdisciplinary courses. Adjustments to faculty workload considerations related to tenure and promotion will also be made to facilitate this.

5. Student Involvement:

- Graduate student organizations will form within these programs to enhance student leadership and community.
- Collaboration with IT is planned for analytics and reporting to track educational outcomes effectively.

Conclusion

This white paper outlines a structured approach to support, strengthen, and expand interdisciplinary graduate programs. By focusing on collaboration, faculty recognition, and student participation, we aim to ensure long-term success and innovation in academic offerings at our institution.

Reports of Officers

FS Chair, Vimal Chaitanya

03 Minutes

On October 25, I attended a Board of Regents meeting where it was announced that President Ferme has signed his contract. He will officially start as president on January 2, 2025, and will visit the campus several times before Christmas. Chair plans to arrange a meeting between the incoming President and our Senate Leadership Committee and will inform everyone once the details are set, as it's important for everyone to participate.

Chair Chaitanya also attended the President's Cabinet meeting, where he gathered information on various topics like deferred maintenance. Moreover, he found out about an Academic Affairs Committee meeting, which he was not invited to but discovered that it was formally known as Academic Dean's Council. This is where he learned about interdisciplinary programs. He is invited to these meetings going forward.

In addition, Chair Chaitanya attended the NMSU Online Advisory Committee, where he talked about a pilot project involving an AI tutor bot. Shortly after this discussion, it was decided to end the pilot project, and the tool has already been deactivated in Canvas to ensure no further accounts can access it.

He also participated in the University System Budget Committee meeting, where a significant request was made by the Athletics Department. He inquired if they followed proper protocols for such requests, and they confirmed that they did. The leadership is focusing on addressing faculty compensation, and some of us may visit Santa Fe to present this matter to relevant committee chairs.

Furthermore, the Chair joined the IT Governance Committee meeting, where the new CIO expressed a desire to improve team efficiency and project planning. He highlighted issues with multiple requests for the same software, recommending a collective approach to procure better pricing. Notably, he mentioned that Windows 10 will no longer receive updates past October 14, 2025, meaning users should consider upgrading their operating systems or devices to avoid security risks.

He also attended the Enrollment Management and MCA monthly meetings.

Additionally, he is part of an International Student Services (ISS) committee tasked with improving support and advisement for international students. This committee is co-led by two Deans and is currently drafting a report that will address our findings and suggestions for better services for these students.

Guest Robbie Grant gave an important brief update on the pilot project. After having some conversations over the last few months and some emails going back and forth., the decision was made this morning to terminate the pilot project on an AI tutor bot and personal learning assistant with check hosted by CHEGG. The tool has already been turned off in Canvas. It has been deleted as well as Honor Shield. They have also removed the integration tool on the back side as well and at this point the pilot has

been terminated and nobody can activate any further.
