## • Recognition of Guests

- Michael Ray, American Indian Program, Indigenous Peoples Day Events 10 Minutes
  - Michael Ray, Director of the American Indian program at NMSU for about 14 years, gave a presentation on the upcoming programming for the Indigenous People's Day.
  - In the past year Memorial 03-23/24 was approved and able to provide funding through the President's office for Indigenous People's Days activity.
  - In the last couple of weeks, they presented before the DEI subcommittee of requesting possible programming that would likely be done.
    - Details of the week-long programs were given with some PPT slides.
      - Monday, October 14, 2024, the opening ceremony will start at 10 a.m. There will be conversations about the importance of Indigenous Peoples Day. How Indigenous Peoples Day became and going into kind of the history behind Indigenous Peoples Day what its meaning is. Lunch will be provided by Alma's kitchen, also a great way to bring the community together when it comes to food being involved. At noon starting on the hour, Northern Southern dance group from Hemis Pueblo will be performing.
      - Tuesday, October 15, 2024, a special lunch & aguas frescas will be served at the American Indian Student Center to bring people together and share that sense of community and that knowledge.
      - Wednesday, October 16, 2024, a meeting with Native American Faculty and staff luncheon to mingle and engage, it is a great way for students to meet the faculty and staff who are Native Americans. Also, if they are looking to collaborate and keep things going when it comes to some of the projects and workshops.
      - <u>Thursday, October 17, 2024, that evening they will be showing</u> the movie The Eagle Huntress. This movie is not necessarily placed in America, but they wanted to look at the sense of <u>Indigenous in a global perspective. The Eagle Huntress is about</u> a Kazakh nomad girl Aisholpan, a 13-year-old is fighting to become the first female eagle hunter in twelve generations of her Kazakh family. There will be a community member from the Pueblo of Laguna coming down and creating a meal that would have been kind of similar to what you would have experienced during their feast days.

- Raghu Raghavan, Facilities and Services, Deferred Maintenance Issues 10 Minutes Raghu Raghavan Associate Vice President for Facilities and Services and chief

facilities officer talked about deferred maintenance.

- First slide: NMSU Current Portfolio Campus is 6.4 million square feet, over 50 miles of infrastructure. 2.8 miles of utility tunnels, most which are connected to the central plant, and they maintain a total of about 5 million square feet of facilities. The average building age is 56 years, the bulk of our buildings are very old.
