## **NMSU Faculty Senate Meeting**

#### **MINUTES**

1. Call to Order - Meeting called to order at 4:01 p.m.

### 2. Recognition of Guests

Diego Medina - Piro-Manso-Tiwa Tribe Land Stewardship

Mr. Medina, member of the Piro-Manso-Tiwa tribe, shared information about their tribe, history and some of their concerns about the landscape, including the issue of the Aggie Uptown development near Tortugas (Turtle) Mountain.

- His family has been here for thousands of years.
- Their culture can be seen as an extension of the landscape itself and of the ecosystem. Their cultural practices are directly tied into the homeostasis of the ecosystem at large.
- The different geographic or topographical indicators and landmarks, plus the landscape, are all ancestors for them and shaped their communities.
- The history of their tribe is significant for the story of the United States. They are the tribe with the longest standing petition for federal acknowledgement.
- Las Cruces is triangulated by three hills, one of them being Turtle Mountain. These hills protect the valley serve as navigational indicators for all the different trade routes that split apart in Las Cruces.
- The Piro-Manso-Tiwa tribe has been aware of and concerned with the development of the land in southern New Mexico.
- The impacts of development on Land in Las Cruces do not just affect the Piro-Manso Tiwa
  people, it affects everyone. These historically and culturally important sites must be
  preserved for future generations.
- Tortugas Mountain is a cultural site where the Piro-Manso-Tiwa tribe hold yearly ceremonies. Tortugas Mountain is a site that connects to important moments in the history of the United States and New Mexico and has an important relationship to everyone living in Las Cruces.
- Tribal sovereignty ensures the protection of water, land, and natural resources for future generations.

Question and Answer session followed.

# 7. Reports of Standing Committees

**Budget and Resources** - Vimal Chaitanya, Chair

Committee met on November 8. Dave Maddox, Financial Strategy and Planning Officer talked about NMSU budget matters, including I&G allocation matters and the I&G sweep cut off, which is currently three percent.

The committee had a discussion about the lack of propositions that are flowing from the upper management.

They concluded that it would be somewhat challenging to try to implement a policy solely for faculty just based on the diverse faculty programs, divisions, and so forth.

<u>Dr. Shuster, Biology, talked about the goal of creating a Center for Excellence in STEM education research. There is a cluster hire going on with new faculty in Math, Computer Science, and TPAL.</u>

<u>Dr. Cifuentes, VPR, discussed the retreat that they had in October.</u> A few things that came up was a discussion of how to make the process for promotion to professor more transparent. Also, the University will be working on defining our institutional strengths.

The VPR asked the committee if they can look into ARP 11.01, Part 1 which addresses research institutes at NMSU. There is currently no clear policy for sunsetting them or evaluating them.
