<u>made before the holiday break.</u>

<u>University Controller- had interviewed at least 3 people. Some concerns raised</u> regarding the qualifications of the candidates in the pool. Interviews to be held early in January.

<u>Director, Procurement Services - a preferred candidate has been selected and the paperwork is being approved through HR.</u>

NMSU President - application deadline for full consideration was Wednesday,

December 6th. Thus far 31 candidates have applied. Semifinalist interviews will take place via Zoom early in January.
