1. Call to Order – Meeting called to order at 4:02 p.m.

Colin King

Colin presented his experience with the NMSU bookstore, which he joined in 2011 as a student, and discussed the integrated course materials program launched in 2015-16. This program has expanded, now operating at NMSU, DACC, and NMSU Alamogordo, and they aim to extend it across the system. DACC has successfully been part of this program since 2021. The program, known as "Books for Success," aims to reduce the achievement gap by incorporating course materials into the fee structure, separate from tuition.

Instructors can deliver materials through Canvas, charging students a fee with potential discounts. The materials are usually available to students on or before the first day of classes, allowing them ample time to prepare. The program prioritizes digital materials, with the option for physical copies if necessary. Students have the choice to opt-out of the program. If the new model is adopted, students would pay a credit hour rate per course.

The program preserves academic freedom, allowing faculty to submit their own material requests. It ensures equal access to educational resources, making it easier for students to get materials without worrying about finances. Currently, over 24,000 unique students are involved system-wide, with high digital usage rates. If implemented system-wide, the fee would be \$28 per credit hour. Compared to traditional costs of \$1,250 for books, this represents a significant savings estimated at \$410 – the difference between the \$840 annual fee for "Books for Success" vs traditional costs for 15 credit hours.

The program in play has been reviewed yearly, and the opt-out rate is low at 1%. The initiative aligns with the university's mission of accessibility and affordability. Students can utilize financial aid to cover costs, and if they lack financial aid, they can use the university's payment plan.

5. Reports of Officers

FS Chair, Vimal Chaitanya

Chair Chaitanya reported on two key issues. The first focuses on the future of

international students and scholar services, specifically helping graduate and international students understand which insurance plans are appropriate and which could violate immigration regulations. The second issue involves a task force created by President Ferme to examine the impact of Trump Executive Orders on NMSU, which Chaitanya and Karen Kopera-Frye are part of. This task force has six groups: one on equity and civil rights, another on U. S. Department of Education functions related to financial aid, a group focusing on immigration, a team addressing the repeal of previous administration actions, one concerned with managing the federal workforce, and a group dealing with matters affecting children and families. The task force will meet both individually and as a whole.

FS Vice-Chair, Christopher Brown

- Vice Chair Brown gave a brief report stating that the U. S. Department of Education is enforcing a rule where financial aid can only fund courses that count toward degrees. NMSU is working how best to implement this rule, and Vice-Chair shared a slide deck related to it.
- The policy review process is facing challenges, with consultations with the University General Counsel due to concerns about potential complaints regarding faculty working conditions and collective bargaining agreement negotiations. Efforts will be made to move forward with non-controversial items.
- In meetings with The President, Provost, and Senate Chair, we also discussed options for graduate student health insurance, with clear guidance expected from the Provost's office before the early May decision deadline.
- Patrick Turner will be leaving the university, and Provost Reddi is seeking ideas on how to adjust the Vice Provost for Academic Success position.
- There's an acknowledgment of the need to explore part-time employee benefits similar to those at another university. Research is being conducted, and results are expected by the May meeting.
- Discussions are ongoing regarding the distribution of a 4% faculty raise passed by the legislature.
- There is also a proposal to remove the credit limit for students with below 3. 0 GPA. Additionally, a graduate grade change replacement policy is under consideration, along with plans to streamline registration paperwork. The full report and slide deck related to U. S. 9. Other Business –

 Open discussion of issues related to Online Advisory Committee called for in Senate Bill 05-23/24 – Vice Chair Brown

Vice-Chair stated that in April 2024, this bill was moved through the Senate and was signed by interim President Gogue, who specified that only faculty teaching for Global should be on the committee. However, this was not communicated to the Vice-Chair, and the matter was not addressed over the summer. In the fall, Mark Lawrence, the committee chair, held several meetings to establish bylaws and a roster, but only Senator Erickson, the bill's author, seemed aware of the situation. Last week, the Senate Leadership Committee proposed using this online advisory committee to discuss global issues with Sherry Kollman. FSLC members involved in these discussions wanted to ensure representation from community colleges and library faculty, as those were outlined in the original bill but were not included when the committee was formed. The FSLC also proposed including a member from the Faculty Senate Leadership Committee. An email was drafted and sent to Mark Lawrence to request these additions, and the Vice Chair is waiting for a response. An update will be provided during the March 24th meeting and the next full Senate meeting.

• President Ferme Inauguration – Chair Chaitanya

Chair Chaitanya provided a brief comment on the upcoming President's inauguration event, which will last for three days. He mentioned that all senators should have received invitations to functions related to this event. If anyone has not received it, they should check their junk box and contact him if needed. He encouraged participation unless there was a major conflict. He also informed that the Senate Leadership Committee, led by Vice Chair Brown, will sit in the front row of the Thursday morning event. While senators are not required to wear legal attire, it is appreciated if they do. Chair Chaitanya has been allotted 5 minutes to speak on the podium and acknowledged the importance of the Faculty Senate and faculty participation in the event.
