d. Temp Faculty Workload Calculation Guidelines

Proposed guidelines were discussed and concerns were voiced by the Senate

Leadership Committee. Some of the concerns include:

- There needs to be a more uniform formula for determining teaching load throughout the university.
- The way it is phrased implies that if you are a full-time faculty, you should be teaching 12 credits per semester and do everything else.
- Whatever teaching load may be standard there should be a phrase in there saying that everything is subject to an allocation of effort negotiated with each individual faculty member.
- We need to have voices in the decisions. What are the tradeoffs?
- The language is confusing. Is it changing fulltime faculty workload? Is it about who is eligible for benefits?
- We want to understand the process better.

The consensus of the Senate Leadership is to push back on this policy and request how do policies get changed and what is that process supposed to look like.

<u>Chair Parra will share the will of the Senate Leadership and their concerns in her</u> response to Provost Parker.
