**Summary of Regents Policy**  **or (ARP) Rule**  **Proposal \***  
**No. 5.90; Title: Promotion and Tenure**  
**Summary:** The proposed changes are the result of the required review of the University's P&T policy which was conducted by the Faculty Affairs standing committee of the NMSU Faculty Senate during the 2015/2016 academic year. It is proposed to update and revise Rule 5.90 together with companion updates and revisions Rules 5.86 (Performance Evaluation-Faculty) and to Rule 5.90 (Promotion and Tenure). The proposed changes include a major reorganization of Rules 5.86, 5.87 and 5.90. The reorganization will also renumber Rule 5.89 to 5.91. A copy of the proposed revision, with a list of specific proposed changes is at the beginning of the attached revised Rule draft. \*At time of submission of this RTF, 5.90 is a Regents Policy; if Proposed Regents Policy 5.00 is adopted by the BOR on May 13, it will become a Rule within the ARP.
